Alaska's Fiscal Regime: Does it work for Industry and Communities?

- State Long-range thinking a community must
- Local tax relief for business and citizens
- Alaska is one highly connected Urban-Rural economic community

Rural Fiscal Issues Local Government Study 1979

- Lack of a tax base "chronic and obvious problem"
- Inability to raise even minimum \$...
- "backlash...financial inequities seen in the provision of education..."
- "Question of village, as well as individual, survival is a critical one"

Why Can't Rural AK pay its bills?

- Extremely High Costs Gas \$5.15 \$6.00/gal
- **Extremely High Unemployment** up to 50%
- Inadequate Property Tax Base E.g., Ambler is assessed at \$3.5 million (i.e. low property values and much non-taxable land.)
- Low revenue from sales tax E.g., Each 1% of sales tax in Ambler nets \$7500/year.

How Are Things Today?

- 2003 Average Operating Budget for two thirds of AK Cities = \$164,000/year
- Approx 03-04 cuts/cost increases: (\$70,000)

 03-04 Eliminate Revenue Sharing
 Fuel/electricity/goods/insurance
 State mandated increases (PERS)
 State fees, service transfers, etc.
 \$2,000

 Far worse in 05-06

Loss of City Governments

Per DCCED as of 3/0513 cities no longer functioning

18 cities in deep debt

39 cities have terminated key local services this year (e.g. police, road/utility/facility maintenance)

Should Anyone Help? AK is one economic community

- Alaskans care about Alaskans failing public safety, utilities, road maintenance, grantwriting, etc.
- Future in rural AK tourism, resources, etc.
- Urban centers are economic "downtown" for rural AK. E.g. Rural AK supports 1 in 5 jobs in Anch/Mat-Su. (Distance draws us closer economically)

What about larger cities and boroughs?

- Among higher per capita <u>local</u> taxes (sales + property) in U.S.
- "No place to go" for many communities due to PERS, oil, rising local % of school operations, etc.
- Local/State tax revolts looming
- Impact on business competitiveness?

PERS/TRS Increases FY 06

Angoon+\$16,000Craig+\$91,000Kenai (city)+\$270,000Fairbanks – Schools/munis+\$2,400,000Anchorage – Schools/muni+\$10,000,000


\$3 billion School/Community debt = \$5,000 per man, woman, child.

Revenue Sharing History (Straight \$, Not adjusted for inflation)

- **1985** \$141,656,800
- **1990** \$ 91,094,000
- **1995** \$ 62,613,500
- **2003** \$ 29,630,700
- 2004 \$ 17,900,000 (1time Fed Funds)
- 2005 \$ 0 (+ emergency oil purchases)

Why Property Taxes Go Up State Cuts to Municipalities vs Local Property Tax Increases 1986-2005

Millions



* "Other State cuts" include: cuts to assistance for libraries, fire services, road maintenance, school bond debt: public

Current Oil Revenue Boom -Burdens all Alaskans

Every \$1 increase per barrel=

- State Revenue = \$60 million per \$1(омв)
- Cost to cities, boroughs, schools, families, businesses = \$20 million per \$1 (US Census)
- So, \$30 per barrel/yr. increase = State Gov't + \$1.8 billion Alaskans (- \$600 million) (highest per capita increases to remote areas)
