Plan Revision Process

- Just beginning the first phase of a 3-year process
- Revising 2002 Plan under the "new" 2012
 National Forest Planning Rule
- Revision is an Opportunity to Evaluate How Current 2002 Plan is Working and If there is a Need for Change

What is a Forest Plan?

- A Strategic Framework that guides forest's day to day resource mgmt.
- A comprehensive plan to guide management over the next 15 years – framework that guides day to day mgmt. operations

Why Revise?

- National Policy Requires Forest Plans be revised every 15 years.
- Revising under the 2012 Planning Rule
- 1 of 8 forests nationwide referred to as "early adopter" forests

What's Different with Revising Under 2012 Planning Rule

3 Phases

- Assessment
 - We are currently in this phase
- Plan Revision
- Monitoring

2012 Planning Rule Highlights

- Designed to take less time/cost less money
- 3 Phase Adaptive Planning Process
- Enhanced public engagement/collaboration
- Outreach to New Audiences/groups
- All Lands Perspective
- Sustainable Rec. as important multiple- use
- Multiple uses & integrated resource mgmt.
 requirements considering full range of values/uses mining, energy, rec, fish,

Emphasis on Sustainable Recreation

- Important multiple use
- Contributor to social & economic sustainability
- Responsible officials must also consider habitat to support hunting/fishing when providing multiple uses.
- Requirements to provide for multiple uses and integrated resource mgmt. considering full range of uses/values including mining, energy, recreation, timber, watershed, fish & wildlife, and subsistence.

Assessment

- Snap shot of existing conditions and identifies issues and trends.
- Non-decisional document
- 15 required elements, ie. social, cultural, and economic conditions; multiple uses and their contribution to local, regional, and national economies; terrestrial and aquatic ecosystems

- What are barriers to use?
- Anything else you want to make a comment on about how the current 2002 Forest Plan is working or is not working.

In Summary

- In revising our Forest Plan we will be starting with the current 2002 Plan.
- We will be determining, from both public, state, tribal and everyone's input, what is working with the current plan and what is not.
- We will use the information from the Assessment AND all the input on the current plan, to build the case for change to revise the Chugach National Forest Plan under the 2012 Planning Rule.

Purpose of Tongass Forest Plan 5-Year Review

1. **Provide Forest Supervisor with insight** into the public's, Tribes' and employees' view of the Forest Plan and its implementation, at the five-year mark

- 2. **Maintain communication** about the Plan and its implementation.
- 3. **Assist Forest Supervisor** in determining whether any actions are needed, at this time, to clarify or adjust the Plan.

Examples of Actions that Could Result from the 5-Year Review

Type of Action

- 1. Provide written clarification of Forest Plan sections
- 2. Plan supplement
- 3. Minor Plan amendment
- 4. Major Plan amendment
- 5. Plan revision

Time to Complete Action

1 to 2 months

1 to 12 months

1 to 2 years

1 to 3 years

4 to 5 years*

1991: Revision SDEIS


1997: Forest Plan/FEIS/ROD


